This agreement is made between Labrador Welfare and the Owner named above.

In consideration of Labrador Welfare agreeing to take over ownership and possession of the dog from me, I agree to make a donation of £ \_\_\_\_\_ to Labrador Welfare to cover their initial costs and expenses.

***The following terms and conditions shall apply to this agreement.***

### 1. **Ownership**

- I am the owner of the dog and am entitled to make this agreement;
- I understand that from the date of this agreement, ownership of the dog will vest in and remain at all times thereafter with Labrador Welfare;
- I understand that the rehoming of the dog will be the sole responsibility of Labrador Welfare and wholly within their discretion.
- I understand as the present owner of the dog that I am giving up my ownership of the dog to Labrador Welfare and that, once done, such is permanent and not reversible.
- I understand that when this agreement has been completed, I will have no remaining rights to the dog, and that this agreement cannot be cancelled.

### 2. **My Responsibilities**

- I confirm and declare that, to the best of my knowledge, the dog has no aggressive or vicious tendencies and is safe for rehoming.**
