

## 100 Club Rules

## 1. Purpose of the 100 Club

The purpose of the 100 Club is to raise funds. Money raised from the 100 Club will be paid into the Labrador Welfare bank account and used to help the Charity to provide services and support which improve the quality of life for older dogs rehomed through the Lifetime Foster Scheme.

## 2. Rules

- a. The 100 Club operates as a small society lottery (registered with North Lincolnshire Council under licence number LOT43504) under the Gambling Act 2005 whereby:
  - Payment is required to enter
  - There is always at least one prize
  - Prizes are awarded purely on chance
- b. The 100 Club is open to subscribers over the age of 18 to join.
- c. For a cost of £5 per month (ie per draw), subscribers to the 100 Club will be allocated one number in the monthly draw understanding that £4 will be used to provide direct support to Lifetime Foster Dogs with the remaining £1 contributing to the prize fund for each monthly draw.
- d. A draw will be made every month with a 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> prize being awarded from the total monthly prize fund which will equate to £1 for every member of the club.
- e. Numbers are limited to 2 per player.
- f. Payment of subscriptions must be made by monthly standing order prior to each months' draw. One month's notice is required for cancellation of monthly subscriptions.
- g. Subscriber's numbers will only be entered into a monthly draw if their subscription has been paid for that month.
- h. If a subscriber misses a payment, Labrador Welfare will assume the subscriber has cancelled their subscription and their number may be allocated to a new subscriber to the 100 Club.
- i. The draw will be made by electronic means on the 27<sup>th</sup> of each month.
- j. Prize winners will be notified within one week by their preferred method of communication as indicated in any recorded GDPR preferences. It is the responsibility of subscribers to let Labrador Welfare know of any changes to GDPR preferences or contact details.
- k. All prizes will be paid by bank transfer.
- Labrador Welfare will not publicise the names of those winners who wish to remain anonymous but may otherwise
  include details of 100 Club wins in the charity's newsletter.
- m. The 100 Club will be run by a nominated member of Labrador Welfare. In case of any dispute the decision of the Trustees is final.
- n. A subscriber will be deemed to have left the 100 Club if their subscription remains unpaid for a period of one month. In this case, personal details will no longer be retained.
- o. If a winner cannot be contacted, the winnings will be placed into Labrador Welfare funds after 3 months.
- p. The Trustees of Labrador Welfare reserve the right to alter the Rules of the 100 Club as may be deemed necessary.
