We sometimes get dogs handed over for adoption that have medical problems which require ongoing expensive medication, or they may need an operation in the future. These dogs are too young to join our lifetime foster scheme but are difficult to rehome because the new owner will not be able to insure the dog for the existing condition. We would like to be able to offer some support towards the cost of these specific conditions. There are also dogs with behavioural problems where professional help is required. If we are able to offer some financial help these dogs will stand a better chance of finding a new home. There are also dogs that for various reasons are in kennels for long spells and a regular donation would help to support their kennelling bills and help us buy enrichment toys and treats.
